



**Chiang Mai University's Regulations on
Maintenance Fees for the International Student Dormitory**

This announcement relates to the fees for the international student dormitories, which is managed under the Student Dormitory Office B.E. 2566.

By virtue of Section 25(3) of the Chiang Mai University Act, B.E. 2551, Clause 8(3) and Clause 9 of the Chiang Mai University Regulations on Chiang Mai University Student Dormitory, B.E. 2563, together with the resolution of the University Executive Board Meeting, meeting no. 8/2023 on 3 May 23, 2023 and the resolution of the Chiang Mai University Council meeting, meeting no. 5/2023 held on 26 May 23, 2023, the regulations were set as follows.

Clause 1 This regulation is called "Chiang Mai University Regulations on Maintenance Fees for International Student Dormitory under the Office of Student Dormitory B.E. 2566"

Clause 2 This regulation shall come into force from 1 May 2023 onwards.

All other regulations, announcements or orders that have already been prescribed in this regulation or which are contrary to or inconsistent with this regulation shall be superseded by this regulation.

Clause 3 In this regulation

"University" means Chiang Mai University.

"President" means the President of Chiang Mai University.

"Student dormitory maintenance fee" means the student dormitory maintenance fee according to the Chiang Mai University Regulations on Financial Management B.E. 2551.

"International student dormitory" means International Student Dormitory according to the University Announcement on Types and Affiliation of University Student Dormitory.

Clause 4 Student dormitory maintenance fees for the International Student Dormitory, which does not include utilities and other expenses, is set at the following monthly and daily rates:

4.1 **Monthly** student dormitory maintenance fees:

(1) International student dormitory, Building A, Superior Room, 8,000 Baht per room (2 people per room)

(2) International student dormitory, Building A, Standard Room, 5,000 Baht per room (1 person per room)

(3) International student dormitory, Building B, 5,000 Baht per room (2 people per room)

4.2 Daily student dormitory maintenance fees:

(1) International student dormitory, Building A, Superior Room, 1,200 Baht per room (2 people per room)

(2) International student dormitory, Building A, Standard Room, 500 Baht per room (1 person per room)

(3) International student dormitory, Building B, 500 Baht per room (2 people per room)

Clause 5 In order to ensure that the administration of the student dormitory fee collection according to these regulations is in order, the President shall have the following powers:

5.1 To prescribe rules and methods for collecting money or making payments or requesting a student dormitory fee refund according to Clause 4, as well as determining the rate of accommodation deposit or collecting such money, and communicate such rules and methods via a university announcement.

5.2 Reduction or exemption or delay or refund of student dormitory fee or accommodation deposit

5.3 Issuing requirements, criteria, methods or guidelines that are not contrary to or inconsistent with this regulation.

Clause 6 In case of necessity, the Chiang Mai University Council may resolve to refrain from applying any of these regulations.

Clause 7 The President shall act in accordance with these regulations.

Anything not specified in these regulations shall comply with the relevant regulations, rules, announcements, orders or policies of the University. In the event that there is an issue to be resolved, the President shall have the power to interpret, consider and make the final decision.
